Everyone is welcome and since this is an annual meeting for all members, everyone can vote and bring up motions for the board. It is a great way to meet your neighbors on the lake. SLMD is our local governing body and we deal with things pertaining to water quality on the lake. Since we are a representative body on the lake, we also can bring issues to the attention of the Town of Marion and Waushara County. There are representatives for both the town and county that also attend our meetings.

The hot topics this year will be Aquatic Invasive Species (AIS) continued and/or enhanced treatment, Goose Population, how best to use the \$10,000 grant money received last year, and **most importantly for many - to vote on whether Spring Lake Management District's members want to ask the Town of Marion to ban property owners from using their properties as Short Term Rental Units (aka STR, like AirBNB, VRBO, etc)**.
