Joint Application of American Transmission Company LLC and Northern States Power Company-Wisconsin, as Electric Public Utilities, for a Certificate of Public Convenience and Necessity to Rebuild Existing Transmission Infrastructure and Construct and Operate LRTP Tranche 1 Project 6, a New 345 kV Transmission Line Connecting the Tremval-Arpin-Columbia Substations in the Counties of

Trempealeau, Wood, and Columbia, Wisconsin, to be known as the Grid Forward Central Wisconsin Project

To the Person Addressed,

The Public Service Commission (PSC or Commission) received an application¹ from American Transmission Company LLC (ATC) and Northern States Power Company-Wisconsin (NSPW) (applicants) for construction and rebuilding work on high voltage transmission lines in central Wisconsin, known as the Grid Forward Central Wisconsin Project. The Commission is sending this letter to property owners along the proposed routes and individuals who have asked to be placed on our mailing list. It is also being sent to public officials in the project area. This letter is also being sent to public officials who may wish to place this notification in a location where it can be viewed by the public.

The project would consist of rebuilding approximately 175 miles of existing transmission lines, which together would support the construction of a new approximately 200 to 205-mile 345 kilovolt (kV) transmission line from the Tremval Substation in Trempealeau County, to an intermediate substation, the expanded Arpin Substation, in Wood County, and connecting that expanded Arpin Substation to the Columbia Substation in Columbia County. Construction would occur in Adams, Clark, Columbia, Green Lake, Jackson, Marquette, Portage, Trempealeau, Waushara, and Wood counties, depending on the route chosen.

An online map and links to project documentation is available on the PSC website.² A list of known special or unique natural or cultural resources that may be affected by the proposed project is attached to this letter.

Public Comments

Commission and Wisconsin Department of Natural Resources (DNR) staff are now analyzing the application and conducting a review of the environmental impacts of the proposed project to include in the draft Environmental Impact Statement (EIS). As part of this effort, the agencies are conducting a public EIS scoping comment process. During this comment period the public is

encouraged to submit comments and suggestions to help the state agencies determine the scope of the EIS.

As part of this effort, the agencies are holding public outreach/scoping sessions throughout the project area. At these sessions, Commission staff will explain the regulatory review process and solicit input from the public to help the state agencies determine the scope of the EIS that must be prepared regarding the proposed project. The agencies encourage persons with local information or environmental concerns to attend the scoping sessions and provide comments and suggestions. The sessions will be held in an open house format. Anyone interested in this proposed project is invited to attend.

There will be additional public comment periods throughout the review process, including comments on the draft EIS and testimony submitted at the public hearing.

Project Description

The applicants have filed an application with the Commission for approval to rebuild approximately 175 miles of existing transmission lines to support the construction of a new 200 to 205 mile 345 kilovolt (kV) electric transmission line from the Tremval Substation in Trempealeau County to an intermediate substation, the expanded Arpin Substation, in Wood County, and connecting the expanded Arpin Substation to the Columbia Substation in Columbia County. The line, if approved, would be constructed, owned, and operated by ATC and NSPW.

The new 345 kV line would be approximately 200 to 205 miles long depending on the route selected. This mileage includes the full or partially rebuilt facilities, which constitute approximately 175 miles of the route, or over 88 percent. The application contains two proposed routes: the Primary Route and the Alternate Route, along with a Common Segment and several

associated Companion Segments that are not unique to any specific route but required to make room for the new 345 line.

The proposed routes cross ten counties and 53 municipalities. The proposed project cost for construction and placing into service is estimated to be between approximately \$1.60 and \$1.63 billion, depending on route selection.

State and Federal Agency Jurisdiction

The proposed transmission line project requires a Certificate of Public Convenience and Necessity from the Commission before construction can begin. The record of analysis of potential environmental and societal impacts will inform the Commission's decision whether to approve, modify, or deny the applicant's proposal.

The DNR will consider the application for wetland and waterway permits, if applicable under Wis. Stat. ch. 30, potential impacts to rare species, and other affected resources under its jurisdiction. The Wisconsin Department of Agriculture, Trade, and Consumer Protection will produce an Agricultural Impact Statement (AIS) under Wis. Stat. § 32.035. The Wisconsin Department of Transportation will consider permits to build in or across state and federal highway rights-of-way and will examine impacts to scenic easements, if applicable. The Wisconsin Historical Society may review the proposed projects for any potential adverse impacts to listed cultural resources under Wis. Stat. § 44.40. Other reviews, approvals, or permits may be necessary from state or federal agencies.

Environmental Impact Statement

The proposed transmission line project is a Type 1 project under Wis. Admin. Code § PSC 4.10(1). An EIS is required as specified under the Wisconsin Environmental Policy Act, Wis. Stat. § 1.11. The EIS will cover the siting and need of the project and all of the associated facilities, as well as potential environmental, community, and private property impacts. The draft EIS will likely be issued in the spring of 2025 and will be followed by a 45-day comment period. Comments on the draft EIS will be used to prepare the final EIS.

When completed, the final EIS will be made available, and a notice of its availability will be provided to the public.

Public Hearings and Commission Decision

In addition to the environmental scoping meetings listed above, later in 2025, the Commission will hold technical and public hearings on the proposed project. The final EIS will be available at least 30 days before the hearings. At least 30 days before the hearings, the Commission will issue a Notice of Hearing. The Notice will include the time, date, and location of the hearings, as well as instructions regarding how to provide testimony for the hearing record. Comments made during this EIS Scoping period do not become part of the record of decision, so members of the

public may want to provide comments now as well as at the later hearing stage of the project review. The Commission must base its decisions about the project, in part, on the record of the hearings. The Commission will discuss the record for this project at a meeting open to the public as it makes its decisions.
